Information We Collect

We do **not** collect personal information directly through this website.

There are:

- No contact forms

- No online booking system hosted on this website

You can browse our website without providing personal information.

Information Collected Automatically

Like most websites, certain technical information is collected automatically when you visit our website.

This may include:

- IP address (anonymised where possible)
- Browser type
- Device type
- Operating system
- Pages visited
- Date and time of your visit
- Referring website

This information is collected through cookies and analytics services where you have provided your consent.

The information is used only to help us understand how our website is being used and to improve the experience for visitors.

Cookies

Our website uses cookies to:

- Ensure the website functions correctly
- Remember your cookie preferences
- Measure website performance and visitor behaviour (where consent has been given)

Analytics

If enabled, we may use website analytics services, such as Google Analytics, to understand how visitors use our website.

Where required by law, these analytics cookies will only be activated after you have provided your consent through our cookie banner.

Data Security

Although we collect very little personal information, we take appropriate technical and organisational measures to protect our website and any data processed through it.

Your Rights
